**Robin Taylor**, Assistant Director, tracks all accounting records, orders Fair merchandise and directs the auction portion of the Corndog Kickoff.


**Julianna Curtis**, Sponsorship Director, coordinates all sponsorships for the Iowa State Fair.

## BACK THE BARNS *Update*

Our construction crews are grateful for the milder winter weather we've had (until January!) as work on phase two of the Sheep Barn's renovation is in full swing. The east side of the building is busy with activity from workers removing the terra cotta for restoration, repairing the masonry, laying blocks in the new restrooms, remodeling the office, repainting the overhangs, and resurfacing the lower roof levels.





While work on the Sheep Barn is slated to be completed by the 2024 Iowa State Fair, the \$25+ million barn restoration project will continue over the next several years with work done in the Cattle, Swine and Horse Barns. You can help support this immense project with a gift to the "Back the Barns" campaign.

# T.A.G. Team

The Blue Ribbon Foundation is once again looking for 100 donors to make an immediate, positive and direct impact on our historic Fairgrounds by tackling a smaller renovation project. Donors might just fall in love with the 2024 project — an update to the official Iowa State Fair “Tunnel of Love,” Ye Old Mill.

Ye Old Mill has been a beloved attraction since 1921. Situated next to the Midway on Grand Avenue, riders climb aboard a boat and disappear into a 1,500-foot tunnel. Except for an occasional collage of historical photos, most of the 3-minute float trip is in pitch-black darkness — allowing bold riders to steal a kiss or two.

While it's considered the Fair's oldest permanent amusement ride, the structure that stands today isn't the original. It was rebuilt in 1996 as an exact duplicate of the original, which had dry rot and termite damage, and was eventually blown over in a strong windstorm. The bright

red paddle wheel remains the only artifact from the original structure.

The current round of improvements includes new sheathing, fascia and architectural shingles on the roof of the main building. The tunnel is next, receiving new sheathing, fascia and a new membrane roof. The side walls of the tunnel will be stripped and repaired where necessary, and new lap siding is planned for both sides. Once the weather warms, the whole structure will be repainted and the “inner” portion of the tunnel that is visible only from the Sky Glider will get a new rock landscape.

For a \$250 donation your name will be listed as a key player in the renovation project and you will receive a commemorative pin to denote your membership in the 2024 T.A.G. Team.

## DONOR PROFILE: BROKEN ARROW WEAR



heard about what happened to the Butter Cow. Is there anything we can do to help? Can we make a special T-shirt?" That simple phone call sparked one of the Blue Ribbon Foundation's most popular merchandise items ever – the Butter Cow Security T-shirt. Broken Arrow Wear printed thousands of yellow shirts, helping raise over \$50,000 for Fairgrounds renovations in August 2013 after the Butter Cow was vandalized. In 2023, their creative staff revamped the shirt for a very popular 10th anniversary edition.

"Typically, months of planning goes into the shirts we create to sell at the Fair," says Kortni Remer, manager of Broken Arrow and daughter of founder Mari Coppola. "But not this time! It was a great opportunity to turn a bad action into something amazing. Our entire staff was all hands on deck to get the shirts put out as fast as possible. At one point, we had every press in our building running the shirt and everyone else folding/bagging. It was amazing to see our staff work together so well; and we all felt proud to be a part of such a great fundraising effort. That experience will be hard to top!"

The success of the Blue Ribbon Foundation is tied to long-time partners like Broken Arrow Wear, a custom screen-printing and embroidery business in Des Moines. Some of the first projects back in 1996 used the pen and ink drawings of the historic buildings of the Fairgrounds. Since then, Mari Coppola and her Broken Arrow team have always strived to create designs that are on-trend and reflect favored aspects of the Iowa State Fair. Kortni was just 10 years old at the time Broken Arrow began working with the Blue Ribbon Foundation. "I would always accompany my mom to do mid-Fair deliveries. I just thought it was so cool to be driving on the Fairgrounds during the Iowa State Fair. It was something that none

of my friends (then or now) could say they've done! I guess you could say I've been working with the Fair for the last 27 years!"

Kortni remembers it was always a tradition with her family to get cheese curds when they visited the Iowa State Fair. She said it was a small part of the whole experience but one they always did together - and the memories have lasted. Now, she is instilling the enjoyment of these small traditions with her family. In 2023 she says, "we took our kids (ages 6 and 8) through the Ye Old Mill for the first time. They giggled the entire ride and thought it was so fun in the dark. I'll definitely never forget their pure joy."

Like Kortni, many of Broken Arrow's staff have special memories of attending the Iowa State Fair with their families, both in the past and more recently. That personal connection to the event makes developing the T-shirts sold at the Fair and participating in the Foundation's T-shirt design competition as judges even more fun, knowing that they play a part in keeping the Iowa State Fairgrounds a showplace for all Iowans. In addition to the T-shirts, Broken Arrow has supported the Corndog Kickoff Benefit Auction as a patron of the event and by printing the bandanas used in the Rags to Riches game.
