
BACK THE BARNs *Campaign*



The Iowa State Fair has a legacy of hosting high-quality livestock shows. As you walk through the barns, one can't help but notice a prominent fashion accessory – Western-style belt buckles. These buckles surpass functionality to show something special about the wearer, highlighting what is meaningful to them from an accomplishment in the ring, their family history or imagery of the animals they work with. These buckles are worn with pride, showcasing who the wearer is and what they want to be.

In recognition of the pride shown by our livestock exhibitors, the Iowa State Fair Blue Ribbon Foundation has created the "Back the Barns" campaign along with a commemorative belt buckle. The livestock barns as a whole will undergo a major \$25 million renovation starting in 2023. Each structure will have dedicated restorations in areas that are vitally needed such as roofing, flooring, electrical, restrooms and tuckpointing, to name a few.

"Back the Barns" is a way for anyone with a passion for youth in agriculture to support the renovation of the barns on the Iowa State Fairgrounds. Providing youth with exceptional facilities in which to compete and showcase their hard work and skills every August is central to the Fair's mission. Renovation of the historic, early 20th century animal barns will give generations of Fairgoers the opportunity to continue the time-honored tradition of showing their livestock at the Iowa State Fair.





The Blue Ribbon Foundation received an initial \$5 million donation from the Richard O. Jacobson Foundation to kick-start the renovation project. Jeff and Deb Hansen and Iowa Select Farms have committed \$2 million specifically for the Swine Barn portion of the renovation. The Foundation will also receive \$12 million from the state's "Rebuild Iowa Infrastructure Fund."

Please back our barns renovation by joining in this campaign to enhance the Fairgoer experience for years to come. Members of the Blue Ribbon Foundation's "Back the Barns" campaign are those generous donors who have pledged \$1,000 per year for three years in support of the Iowa State Fair's historic livestock barn restoration project. While the individual venues undergo many upgrades, the historic value to the structures remain intact.

Prairie Meadows has also donated to replace worn down benches with wood-grained recycled plastic planks that have a substantially longer life expectancy and require little maintenance. All of these little repairs improve a Fairgoer's experience during their visit to the Iowa State Fair. Many of the building and grounds enhancements have also allowed the facilities to be utilized year round.

The generosity of Prairie Meadows to the Iowa State Fair is critical for maintaining and growing this institution for generations to come.
