For 171 years the Iowa State Fair has been committed to maintaining our heritage with the "tried and true" and embracing innovation with the "new and improved." While tradition creates a sense of stability and connects us with our past, transformation helps us adapt to changing environments and find solutions for future prosperity – but the two must go hand in hand. **Drew Sniezek**, Communications Manager, organizes giving programs and oversees all communications and event planning.




# JOIN US IN MAKING A *Difference*

An exciting, inclusive “Variety Star Playground” will be built on the Iowa State Fairgrounds in 2025! The Iowa State Fair Blue Ribbon Foundation is thrilled to announce a new partnership with Variety – the Children’s Charity of Iowa to create a special addition to the Fairgrounds.

Dedicated to offering something for everyone, the Iowa State Fair will update the current Fun Forest play area to be accessible for all. This new playground will allow children and adults of all abilities to enjoy playing together, creating an environment that encourages connection and fun.





During the Fair, the Fun Forest is a haven where parents can relax while kids explore beyond the stroller. But the playground isn't just for August – it's a year-round destination for families, especially those on Des Moines' east side.

The new playground will have an agricultural theme with farm animals, complete with an accessible ramp and a smooth, easy-to-navigate surface designed to inspire outdoor play and creativity. It will be a space that encourages physical activity, imagination and friendship.

**Our goal is to raise \$300,000 of the \$700,000 cost for the project. Variety will raise the remaining balance. Thank you in advance for supporting this project.**

# PROJECT *Updates*

**Back the Barns:** Progress continues for the livestock barns renovation project. The Blue Ribbon Foundation's "Back the Barns" fundraiser is an opportunity for those passionate about supporting youth in agriculture to contribute to the renovation of these important structures. Providing outstanding facilities for young people to compete and showcase their hard work every August is at the heart of the Iowa State Fair's mission.

**Sheep Barn:** The two-year, \$6.2 million renovation was completed in the fall of 2024.

**Horse Barn:** The two-year, \$13.1 million renovation project includes the following:

- Masonry, sheet metal, and roofing restoration
- Exterior and interior painting
- Repair and replacement of exterior doors and windows
- New concrete floor with radiant heat
- New relocated offices on the west end
- Remodel existing restrooms and add new restrooms that meet current accessibility standards
- Relocate covered outdoor wash rack and add a new interior wash rack area
- New portable stalls
- Enhance ventilation
- New electrical service and lighting
- New fire suppression system

Phase one of the project (exterior painting, window replacement, masonry repairs, and north restroom renovation and construction) will occur prior to the 2025 Iowa State Fair. Phase two, encompassing the rest of the project, will begin immediately following the 2025 Fair and be completed in time for the 2026 Iowa State Fair.

**Earth Home:** The Blue Ribbon Foundation office underwent essential renovations to enhance its appearance and functionality. Deteriorating shake shingles and siding on the main Earth Home and nearby garage were removed and replaced. New cedar shingles were installed above the front door, and durable, low-maintenance metal roofing was added along the front façade.

The garage also received updates, including new siding and flat roofing. Inside the office, all common-area ceilings and walls were refreshed with a coat of paint, giving the space a bright, renewed look.

## DONOR PROFILE: BOB'S SEPTIC



ith the tagline "We. Get. It. Done." Bob's Septic isn't just a company that does its job – it does it well and goes the extra mile when nature calls.

Starting in 1973, Bob Davis worked part-time with one septic truck, taking care of the Berwick community. More than 50 years later, Bob's Septic has grown into the leading provider of porta-potties and portable restroom trailers in Central Iowa and the Des Moines metro area.

Today, Jason Shepherd, Bob's son, owns and operates the business on Des Moines' east side. Jason's connection to the Iowa State Fair began early in life. While most kids attend the Fair for corndogs and midway prizes, Jason joined his father in servicing the campgrounds. The Iowa State Fair Campgrounds is home to some of the Fair's most passionate attendees, forming a unique and vibrant community.

Bob's Septic was the first company to handle waste removal for the campgrounds, a service that continues to this day. In addition to pumping waste, the company now provides porta-potties, handwashing stations, and maintenance support across the Fairgrounds.

"The Iowa State Fair is always top of mind for us," said John Davis, Marketing Director of Bob's Septic. "We start preparing six months in advance, and during the Fair, our staff works 16-hour days for all 11 days." Despite long hours, the Bob's Septic team still finds time to enjoy the Fair by gathering at their favorite spot, JR's SouthPork Ranch.

"This business feels like a family," said Davis. "The Iowa State Fair strengthens that bond. When we're doing our job well, the average Fairgoer won't even notice – but it's the behind-the-scenes work that makes the event shine."
